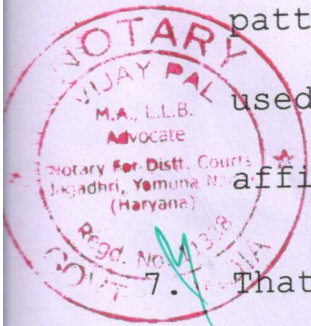

affiliation & examination byelaws, directions issued from time to time and the law of the land.

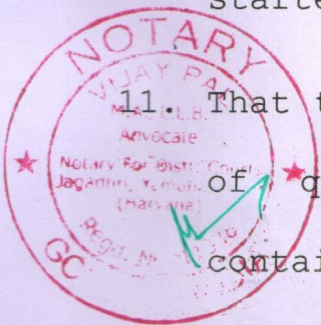
8. That the company will ensure compliance of all statutory requirements like EPF, ESI and Labour Laws etc with respect to the company and staff of the company.

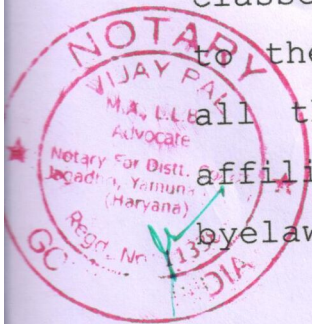
without resorting to any hidden charges in the heads of the fee.
